

Rules and Regulations:

1: Your completed signed and/or electronically submitted Application Form is your ACCEPTANCE, on behalf of your entry and all your entry's participants, of all Sunsites Christmas Parade (SCP) Rules and Regulations.

2: All instructions of SCP officials must be obeyed. Failure to do so will result in removal from the Parade and may jeopardize participation in future parades. Safety is our first priority ---- Your Safety and our Spectator's Safety! SCP officials reserve the right to remove any entry at any time, whether as a result of safety concerns, interference with the Parade's progress or any other reason that SCP officials deem appropriate.

3: On Parade day, each entry must be accompanied by a **Responsible Adult** (as identified on the Parade Application) who is in charge of the entry and responsible for their participants' knowledge of and compliance with the Rules and Regulations of the SCP. The **Responsible Adult** must be designated and responsive to SCP official requests.

4: The **Responsible Adult** will ensure adequate adult supervision of all children participating in his/her entry.

5: All parties are prohibited from handing out materials (flyers, goody bags, etc.) during the parade unless pre approved by SCP.

5A: If materials are allowed to be distributed, participants must stay walking along the route and hand them out. No throwing of materials is allowed.

6: If participant is on a float, vehicle, etc, participant must remain on it at all times during the parade. Participants may not get onto a float, vehicle, etc. during the parade either.

7: All Parade entries shall exhibit proper disposition and control of all animals in the Parade environment without assistance.

General Release

In consideration of acceptance of participation in the Sunsites Christmas Parade, I hereby release and shall defend and indemnify the Sunsites Community Association and Sunsites-Pearce Fire Department from all and every claim for damages which may be made on my behalf or on behalf of any individual under my supervision at any time hereafter against said organizations, their officers, and members, or any of them, by reason of any matter, thing, condition, negligence, or default, or any person whatsoever, in the Sunsites Christmas Parade, or any of them given by, or under the direction of the

said Sunsites Christmas Parade Committee, in connection with the above described parade. In addition, I understand that there may be pictures, photographs, videos and/or other depictions or images taken or made of the below described entry in connection with this parade (generically "Images") and I hereby consent to all such Images and waive all claims, if any, that I may have in connection with their creation or use.

Finally, I knowingly and voluntarily agree to and accept the foregoing conditions of this contract.

Minor Release

I acknowledge that the Sunsites Christmas Parade is potentially dangerous and may result in serious property damage, personal injury and/or death. Being fully aware that my child's participation in the Sunsites Christmas Parade may be dangerous, I hereby release the following from any and all liability for property damage, personal injury, death, or any other claims arising from my child's participation: The Sunsites Community Association, Sunsites-Pearce Fire Department and all sponsors of the Sunsites Christmas Parade and any such entities, affiliated, related or subsidiary companies, as well as such entities, insurance representatives, insurers, directors, officers, employers, representatives, agents and assigns.

In addition, I understand that there may be pictures, photographs, videos and/or other depictions or images taken or made of my child in connection with this parade (generically "Images") and I hereby consent to such Images and waive all claims, if any, that my child or I may have in connection with their creation or use. Furthermore, I, my spouse, dependents, representatives, heirs, successors and assigns shall not prosecute, directly or indirectly, now or at any time in the future, any action, suit or proceeding arising from any injury, loss or damage, suffered by me, or them regardless of cause, against the before mentioned entities during Sunsites Christmas Parade and related activities.
